An unusual twist to this year's dedication will be that the Arts and Crafts Building will not bear the name of the people who donated the money to build it. These generous friends of the Ranch prefer to remain anonymous, but they will be on hand, and will have an opportunity to see how much their gift is appreciated.

The public is of course invited to the barbecue luncheon at 12:30 p.m. which will be followed by the dedication ceremonies at 1:30 p.m.



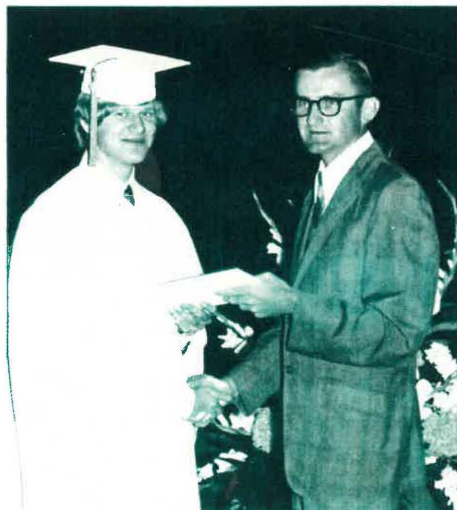
The boys and staff spend a lot of time preparing for this annual event because it is their chance to say "Thank You" to the people who make it all possible.

"Friend Raisers" Organized

BARTOW — Enthusiasm for the Florida Sheriffs Girls Villa is running high. The first girls have been selected, Girls Villa Week is approaching and just about everyone wants to do his part.

People are donating citrus trees, oil paintings, clothing and money; while others are cleaning out canals, building docks, painting fences — the list is endless.

As a result of this intense interest, a Board of Associates has been formed—not as fund raisers, but as "friend raisers."

The Board is composed of about 35 community leaders from many fields who will be closely involved in the Villa program and be able to interpret that program to others.

Bill Stringfellow, a supporter from the

first time this city was mentioned as a possible site for the Villa, is the first Chairman and Polk County Sheriff Monroe Brannen is serving as Ex-officio Chairman.

Executive Director Harry Weaver believes that by bringing together the opinion holders of a community the Board will be able to influence the climate of that community toward the Villa.

The associates will make positive contributions by (1) providing two-way communication between the Villa and the public (2) giving advice to the Villa as it faces major issues (3) providing counsel to the resident director and (4) by functioning as a center of influence for the Villa in their respective communities, businesses, professions or churches.

WHERE THERE IS A WILL

When it comes to raising money, Florida Sheriffs Boys Ranch and Girls Villa supporters seem to have an infinite variety of methods to aid their cause.

Proceeds from a central Florida airboat race were donated to the Ranch.

A horse show sponsored by Buck and Carol Harris of Bo-Bett Farm turned over a sizable donation to the Ranch.

The Zonta Club of upper Pinellas County is raising money for the Villa by collecting trading stamps, bonus coupons, cigarette coupons and the like, then redeeming them for cash.

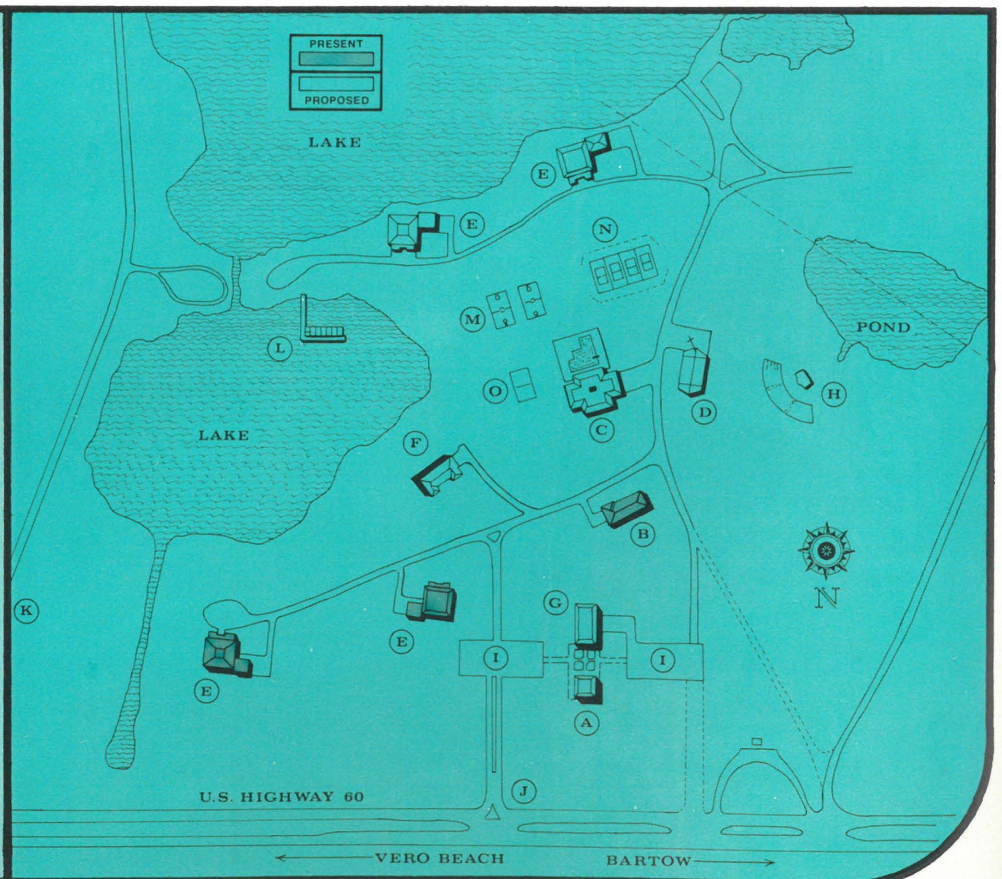
Two Dade County bailiffs, Michael Wahl and Bernie Sutta, sold Body Guard tear gas spray guns and turned the profits over to the Ranch.

VILLA ADMISSION POLICIES

BARTOW—Now that the Girls Villa is open and the second cottage is already under construction, a lot of people are interested in knowing how to go about getting a needy girl enrolled.

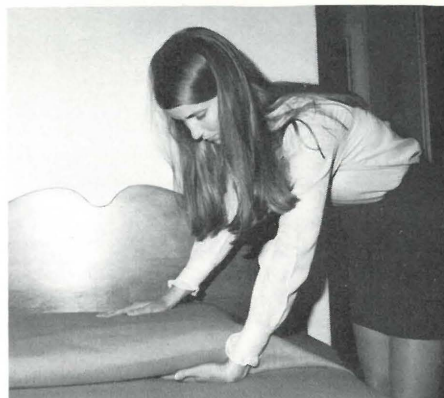
Requests for admission usually come through the office of the Sheriff in the county where the girl lives. A child care agency, parent, friend, school or minister can recommend a girl.

Applications can be obtained from a sheriff's office. The Villa social service department will act upon the application, collecting pertinent information from interested parties and holding interviews with the girl and her family.

The final decision is up to an Admissions Committee of Villa staff members.

General requirements are that the girl be at least eight years old but not over 17. She must be in good physical and mental health and be able to perform adequately in public schools. Residency in the state is required along with approval by her respective sheriff and juvenile court judge.

She should be in need of placement outside her home, but must not have been adjudicated delinquent.



LOTS TO DO AT THE VILLA

BARTOW — The Florida Sheriffs Girls Villa is more than just a place to live — it is a place to learn and have fun.

A girl learns responsibility by making her bed and keeping her room clean; by washing and ironing her own clothes and by helping with the shopping and cooking.

For recreation there is horseback riding, boating and bicycling with facilities to be added for swimming, basketball, tennis and volleyball.

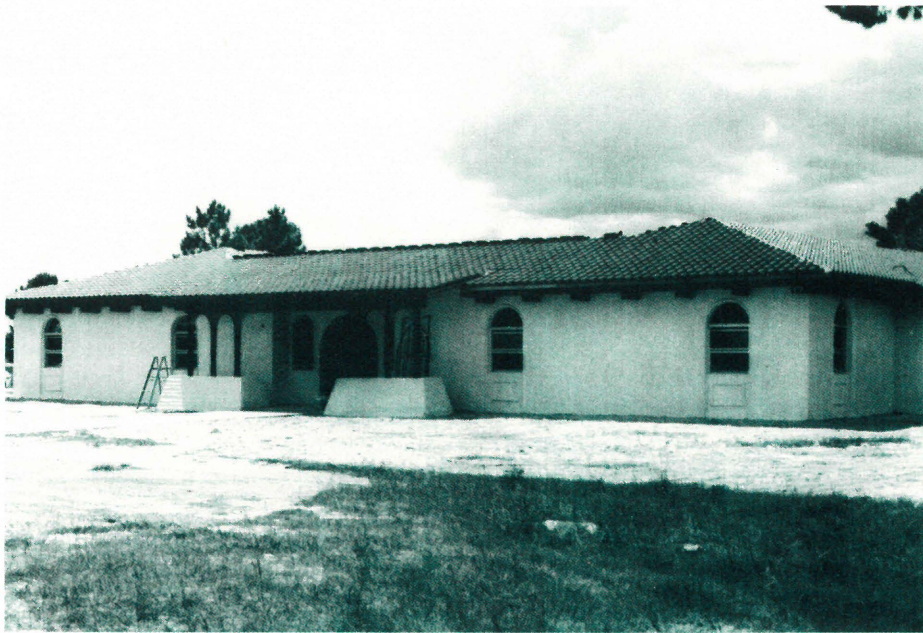

EVENT-PACKED VILLA WEEK STARTS AUGUST 26

BARTOW — Almost as soon as the first annual Girls Villa week was over last year, supporters began planning to make this year's celebration even bigger, better and more successful than the first, which raised over \$15,000.

Highlight of the week will be the official dedication of the Pinellas Sunshine Villa cottage on August 27, at 3:30. The first girls were admitted in mid-July and construction is already underway on the second cottage to be known as Buena Vista.

The same Sunday, George Jones and Tammy Wynette, stars of the country and western music world, will present a benefit performance at their Old Plantation Music Park near Lakeland.

Proceeds from the benefit and all other activities during the week will go to the Villa.

Kicking off the event-packed week will be the Miss Bartow Beauty Pageant on August 26. Other events during the week will include the annual press golf tournament; a joint civic club luncheon; a tournament for women's golf teams; the Annual Girls Villa Golf and Tennis Tournaments and the Girls Villa Ball, featuring Danny Davis and the Nashville Brass.

The Pinellas Sunshine Villa is being named in honor of the women in the Sunshine State Chamber of Commerce

of Pinellas County who first conceived the idea of a facility for girls similar to the Florida Sheriffs Boys Ranch.

Funds for the construction of the second cottage were made available through the generosity of The Peebles Foundation, of Vero Beach, A. R. Jones, President; Betty P. Jones, Secretary.

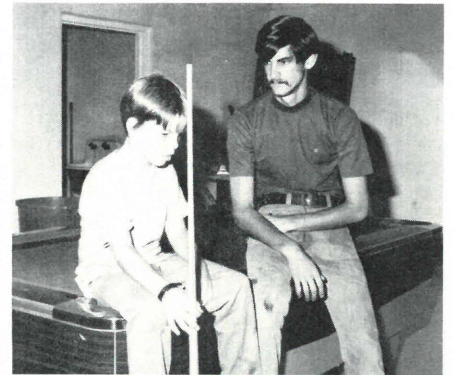
SCOTT'S TURN NOW





Besides giving the boys a chance to earn extra money, Weaver believes it will build their self-confidence.

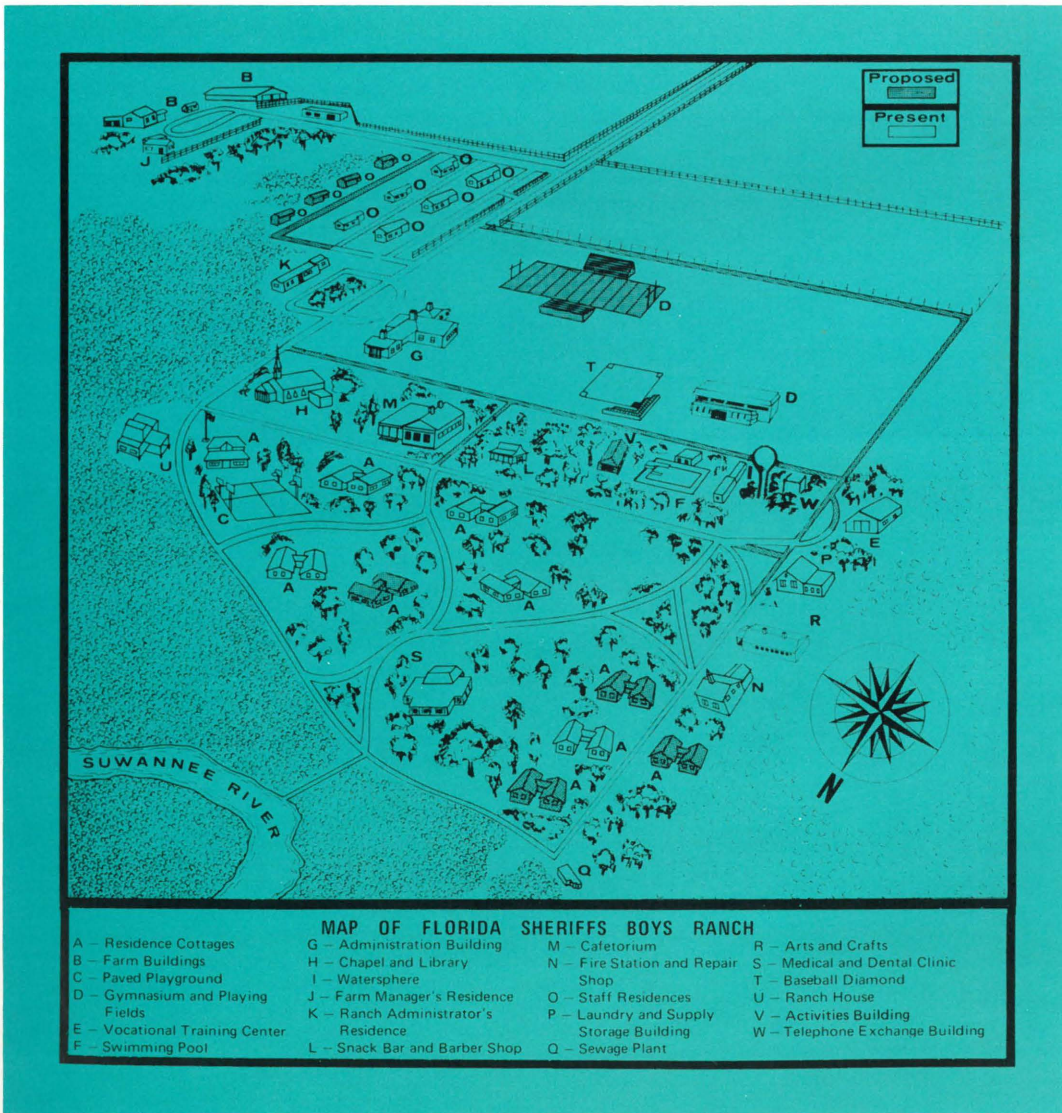
The expanded center will permit the Ranch to service all its own vehicles—from lawn mowers and pumps to trucks and tractors.

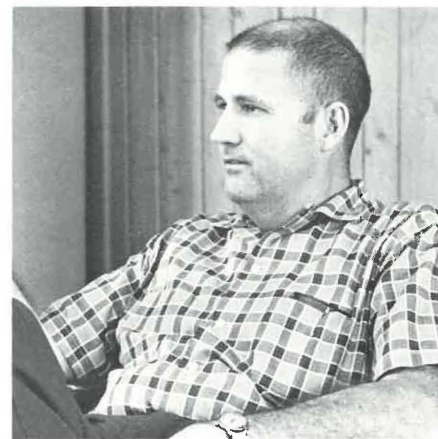

THE BIG QUESTION

Questions come in all shapes and sizes. Not a day goes by that we don't answer some by letter, by phone and in person—and we do it with pleasure, because a person who asks questions is a person who cares.

How many boys do you have? What kind of families do they come from? How do you select them? What are the age limits?

Some questions are important, some are relatively unimportant, but always there is one that stands out above all the others.

To ask it is to probe the deepest foundations of the Boys Ranch.

To answer it is to tell what the Boys Ranch is all about.

"How do your boys turn out?" That is the big one, and we don't just answer "good", or "fine", or "all right". The person concerned enough to ask "the big one" deserves more than a one word answer. He deserves to know that the vast majority of our graduates are living useful and productive lives as law-abiding members of society. He is also entitled to know that there is no such thing as a perfect score in this business of raising boys.

We are always quick to admit that some boys continue to have serious problems after they leave the Ranch. We are not immune from heartaches and disappointments, but we also don't give up. We never lose faith because we know that people are never too old to change.

When we tell people how our boys are turning out, we use a long yardstick. We don't just talk about how many have been graduated from high school, technical school or college. We also talk in terms of how our former Ranchers are doing as fathers, as husbands, and as responsible citizens in their respective communities.

We try to look at the total picture, because we too want to know how our boys are doing. Their success is a measure of our success, and we follow their progress in many ways — through letters, through personal contacts, and especially through the annual meetings of the Boys Ranch Alumni Association.

In ranching terminology, an alumni meeting such as we held here in May is like an annual "spring round-up", and we watch our "grads" returning to the "old corral" with much interest. Some bring their wives, some bring their wives and children, some come in military uniforms, and some seem to drift back to this original point of departure as though seeking to regain their compass bearings.

Observing the ones with wives and children has convinced us that former Ranchers are likely to make good husbands and fathers. Vivid memories of childhood hardships and bad breaks seem to make them determined to provide a secure and happy home life for their own children.

Listening to former Ranchers in Alumni Association business sessions; in late night conversations when the talk becomes personal and serious; or over meals in the Ranch cafetorium, we often marvel at their maturity.

They represent many backgrounds — law enforcement, accounting, printing, sales, skilled trades — and yet they communicate well.

They show concern for each other, and for the young Ranchers who are following in their footsteps.

They are perceptive, especially when it comes to understanding the needs and the purpose of the Boys Ranch.

And, most important of all, they seem to be turning out just the way we hoped they could.

That answers "the big one" for us.

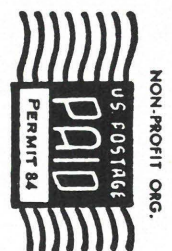
