

# President's Perspective

A message from Harry K. Weaver, President of the Florida Sheriffs Youth Ranches



Across America financial unrest is taking its toll on individuals and businesses. The economic picture nationwide is one of growing unemployment, shrinking investment income and vastly increased demands on child care services.

The Florida Sheriffs Youth Ranches family is not immune to this critical economic climate. In the wake of this depressed economy, the Youth Ranches current income is shrinking too, which means we have less funds available to help troubled boys and girls. This comes at a time when Florida's children rank among the highest at risk groups in the nation, and our service demands for the care of troubled and neglected youth have drastically increased. I am personally receiving calls each week desperately asking for help with a troubled boy or girl.

The lifeblood and sustaining force behind the Florida Sheriffs Youth Ranches has always been the loving generosity of our donor family, the same people and businesses that are now struggling with financial concerns of their own. As a result our donor gifts are down from previous years. We are fortunate, however, that the faithful support of our donor family and the Youth Ranches proven record of success in salvaging boys and girls lives over the past 35 years finds us in better shape than most charitable organizations.

Nationwide, this economic slump has hurt charitable giving. The Non-Profit Times/Barna Research Group's recent agency survey reports an across the board 40 percent decrease in giving for the first quarter of this year. The Research Group identified an overall drop of 19 percent in giving to charitable organizations between 1990 and 1992.

This downturn in current gifts is forcing us to scale back our operations statewide to assure that quality care to the boys and girls in our programs is maintained. We will be reducing the intake of youth awaiting admission into our residential care programs, as well as reducing our staff to keep our expenses in line with our income. As always, we are constantly examining and instituting measures that will economize on our operational expenses while preserving our services.

We hope and pray that this is a short-term setback, as we are committed to serving as many troubled boys and girls as funding permits. Reuniting families and creating opportunities for successful living for troubled youngsters is what the Florida Sheriffs Youth Ranches has done for over 7,500 boys and girls since 1957.

The Florida Sheriffs Youth Ranches is pursuing every avenue of attracting additional current income and new donors, along with the assistance of the Florida Sheriffs Association and our thousands of friends and volunteers. There is some good financial news — our Opportunity Stores (Thrift Stores) and Gift Annuity Program are doing well. More and more friends are including the Florida Sheriffs Youth Ranches in their wills and trusts. We extend our heartfelt thanks to all of you who have been loyal friends in the past and are continuing to help us preserve this vital service to young people.

# Arnold Bauer's bequest has aided hundreds of boys and girls

During his life, Arnold M. Bauer gave generously of his time and resources to help Florida's youth. When he passed away at the age of 91 in 1985, the long-time Stuart, Fla., resident assured his legacy of giving would live on through a \$2.5 million dollar trust fund. The Florida Sheriffs Youth Ranches, Inc., shares equally in the proceeds of that bequest with the Martin County YMCA and the Gulfstream Council of Boy Scouts.

Mr. Bauer relished his work with young people. He founded the first Boy

Scout troop in Stuart and served for many years as its leader. To gain firsthand knowledge of survival camping to pass along to his scouts, he lived and worked among the local Indians for several weeks, learning how to hunt, fish and track.

As the Royal Ambassador of the Stuart Baptist Church Youth Group, Mr. Bauer taught Sunday School classes for many of his 43 years in Stuart. He

> rewarded boys who learned their Bible verses and attended classes regularly with fishing and camping trips.

> Mr. Bauer owned the Frigidaire dealership and founded the First National Bank of Stuart. He became Vice President and one of its first directors. Prior to moving to Florida from Bridgeton, N.J., where he served on the City Council, he owned and operated one of the largest hardware stores in southern New Jersey.

> Since Mr. Bauer's death in 1985, donations from his trust to the Florida Sheriffs Youth Ranches, Inc., have totaled about

\$400,000. Unquestionably, Mr. Bauer's loving generosity has aided hundreds of boys and girls for whom he had so much concern, and will continue to provide loving benefits for many years to come.

River Youth Ranch on October 1, 1991. This was the first opportunity for donors and the public to tour the recently renovated facilities. Special ceremonies also honored the dozens of people and organizations who originally fostered the Manatee program.

Development of the former Manatee River Youth Ranch began in 1984 through the generous support of the Kiwanis Club of Bradenton and a lease/license arrangement with Manatee's Board of County Commissioners. After a series of meetings between Manatee's Commissioners and the Florida Sheriffs Youth Ranches, a merger ensued. In September of 1991, the legal transfer of the 99-year lease/license made it official.

Guests toured the campus of the 60-acre Youth

Ranch which currently includes the Aurora Cottage and Selby Horse Pavilion, both completed in 1990, and the future site of the McCune Maintenance/ Vocational Center. Following the award presentations, guests enjoyed refreshments and fellowship with youths currently living at the Youth Ranch.

The Florida Sheriffs Youth Ranches, founded by the Florida Sheriffs Association, celebrates its 35th Anniversary this year. Its mission is to provide quality group care and family services for troubled, dependent, neglected and homeless children between the ages of 8 and 17, who have not been adjudicated as delinquent. Financial support for the Youth Ranches is derived almost entirely from voluntary gifts.

# Capitol visit focuses attention on Youth Ranches 35th Anniversary

Amidst the hustle and bustle of the 1992 legislative session in Tallahassee, a handful of Youth Ranchers were treated to a rare glimpse behind the scenes. The primary purpose of their visit to the Florida Capitol in early February, was to focus attention on the 35th Anniversary of the Florida Sheriffs Youth Ranches which will be celebrated October 2-4, 1992, but they also got a lesson in government, and an even more important one, in human compassion.

"I thought the legislators would be stuck up," admits Jonathen Freeman, an 8th grader at the Boys Ranch near Live Oak.

"I found out they really care about us and that we are making something out of our lives."

Twelfth District State Representative Randy Mackey agreed, "The youngsters kept asking me why I would want to spend so much time showing them around. I told them that what goes on in Tallahassee is important, but what goes on in lives of youngsters at the Youth Ranches is even more important. Young people can tell in a hurry if you are faking. I'm glad they saw the real concern we have for them and their lives."

Rep. Mackey, an enthusiastic Youth Ranches supporter, sponsored a resolution commending the 35 years of dedication demonstrated by the Florida Sheriffs Youth Ranches and its sponsor, the Florida Sheriffs Association. Also praised were the generous donors who have given troubled and neglected boys and girls a second chance at a successful and stable life. The Youth Ranchers were interested spectators as the resolution, co-sponsored by Rep. Mackey and State Senator Sherry Walker, Fifth District, was passed unanimously by both houses.

"Floridians need to realize if we don't give youngsters like those served by the Youth Ranches a chance, we are just throwing away our future," Representative Mackey added. "I've heard some of




A tour of the Florida History Museum was one of the highlights of the Capitol visit.

the life stories of these kids, it is enough to tear up your heart.

"I asked one girl where her home was and she told me the Youth Villa in Bartow. That says a lot for the loving dedication and hope for the future that's instilled in these youngsters. That's the best





recommendation in the world for keeping this second chance program thriving."

Thirteen Learning Center students from the Boys Ranch near Live Oak, the Youth Villa near Bartow and Youth Ranch in Safety Harbor participated in the one-day field trip. They were accompanied by Youth Ranches staff. In addition to a firsthand look at the Florida Legislature in operation, the students toured the state Capitol.

"We visited the Florida Museum. It was my first visit to Tallahassee. It was bigger than I expected," explained Eric Nichols, an 8th grader at the Boys Ranch. "We saw real gold, not faked exhibits, but real gold and silver from those sunken ships off the coast."

The hectic schedule of legislative sessions and touring the government offices still left the boys and girls time to enjoy lunch in the Capitol cafeteria and to pretend they were important state officials.

"We got to sit in the legislators' chairs, stand behind the Speaker's podium and use that gavel. We even toured Governor Lawton Chiles' office and sat behind his desk," added Eric. "The best part was that legislators and other people like Secretary of State Jim Smith weren't too busy to spend time with us. They really care."

The Youth Ranchers visit with Secretary of State Jim Smith was graciously arranged by Assistant Secretary of State Beverly Burnsed-Spencer, who currently serves as a member of the Florida Sheriffs Youth Ranches Foundation Board.

## Suwannee County plans major Youth Ranches birthday salute

LIVE OAK — A group of key Suwannee County leaders is planning a major celebration commemorating the 35th Anniversary of the Florida Sheriffs Youth Ranches.

Suwannee County is where the Youth Ranches began in 1957 with the founding of the Florida Sheriffs Boys Ranch near Live Oak, and the residents of this county have always been loyal supporters.

During the next few months leading up to the annual Boys Ranch Open House and Horse Show on October 2-4, 1992, a major public awareness campaign will be launched by the Suwannee County group, including arts and crafts exhibits, pictorial displays, community events, sporting activities and speaking engagements.


# Dedication inaugurates new Caruth Campsite

INGLIS — "To the Glory of God we dedicate this Whitaker Campsite," said Harry K. Weaver, President of the Florida Sheriffs Youth Ranches, during a ceremony dedicating the new Whitaker Campsite at Caruth Camp, on Sunday, March 15, 1992.

The Whitaker Campsite is the second to be completed at Caruth Camp. Its five wood-frame cabins are laid out to form a circle, and are joined by an elevated wood walkway constructed by the boys. One cabin is used by staff counsellors, another is used for limited cooking and group meetings. Each of the remaining cabins can house three boys. During the day, the boys proudly escorted visitors on tours and answered questions about their new living quarters.

A generous estate gift from the late Raymond and Myrtle

Whitaker helped to finance construction of the new campsite.

Their nephew, Mr. John Butts of Hawthorne, FLA., spoke on their behalf. "They would be so proud to see how their contribution is helping these young boys," he said. "My uncle was great about helping out young people."

Approximately 300 friends, supporters, campers and staff gathered outside the Mallory Unit Building for the dedication ceremony.

Sarasota County Sheriff Geoffrey Monge, Chairman of the Youth Ranches Board of Directors, served as Master of Ceremonies. He introduced Ms. Sally Clacher, President of Caruth Camp Board of Associates, who led the audience in the Pledge of Allegiance.

The keynote speaker for the afternoon was James T. "Tim" Moore, Commissioner of the Florida Department of Law Enforcement. He discussed Florida's crime problems, and applauded the Youth Ranches for providing an alternative for troubled boys and girls.

"More than 7,500 young people have been educated, counselled, housed and sheltered since the statewide child care agency was founded in 1957," Moore said. "The Youth Ranches continues to be a positive force for change in our communities after


almost 35 years of service to youngsters," he added.

The visitors were treated to an entertaining songfest provided by the Caruth Camp Trail Blazers and Pioneers. The Camp's program includes Boy Scout training, and all the boys proudly turned out in their Scout shirts and caps.

Several of the boys played their "Bac Pac" harmonicas with a guitar and tambourine accompaniment. The audience truly enjoyed singing along with a rousing rendition of "When the Saints Go Marching In."

At the conclusion of the dedication ceremony, the audience proceeded down the "Wilderness" roadway to the campsite for the ribbon cutting.

Mr. Weaver officially dedicated the campsite and Mr. Butts cut the ribbon. Donors who helped to finance the campsite in addition to the Whitakers included the Dunspaugh-Dalton Foundation, Lockheed Employees' Bucks-of-the-Month Club, the Calkins Foundation and the Boeing Employees' Good Neighbors Fund.

# "Hamburgers-for-handiwork" swap produces \$80,000 labor of love

resident Harry K. Weaver swears he has not used smoke or mirrors or magic incantations to raise millions of dollars during his 31 years at the helm of the Florida Sheriffs Youth Ranches — it only looks that way.

Take for instance that incident down on the Suwannee River last year when he traded a few hamburgers and some friendly chit chat for \$80,000 worth of skilled labor.

This "sweetheart of a deal" started when Weaver and Boys Ranch residents were having a cookout on the riverfront and a group of cruising canoeists halted nearby for a rest.

Noting that they looked tired and hungry, Weaver asked the cookout chef, "Do we have enough to offer them some?"

The chef said "sure boss," or something like that, and the canoeists accepted an invitation to share the vittles.

By a rare coincidence, one of the canoeists was a member of the Mobile Missionary Assistance Program (MMAP), and when he was told about the objectives of the Youth Ranches, he urged Weaver to get in touch with MMAP as an excellent source of free skilled labor.

He explained that MMAP is an organization of retired Christian couples who cruise the North American continent in recreational vehicles (RVs) and serve God by working on repair, renovation and construction projects for Christian churches, camps, missions, child care agencies and similar groups.

They travel in groups, he said, and provide their own housing and food; charging nothing for their labor, and requiring the hosts to provide only parking space, utilities and building supplies.

So that's how the "deal" began. It wasn't an immediate swap of hamburgers for handiwork, but there seemed to be a touch of divine intervention in the way it worked out.

MMAP headquarters, located in Pasadena, Calif., was contacted, and invited to send some of its roaming repair groups to the Boys Ranch.

The response was favorable, but first the MMAP officials had to be reassured that the nondenominational religious policies of the Boys Ranch were acceptable. A MMAP representative verified this in November 1991, and the first group of five MMAP couples rolled through the Boys Ranch archway on January 3, 1992.

What a group!

In its 34-year history, the Boys Ranch has been invaded by thousands of people bearing gifts — cows, horses, checks, stock certificates, clothing and so on — but this was something new. These marvelous mobile missionaries brought their own tools, an aura of friendly benevolence, and an "eager to work" attitude.

Almost before the initial handshakes had cooled they were at work, and it wasn't just polite "busywork" to make them think they were performing a service. The men tackled a major renovation project at Lewis Cottage, one of the oldest residences for boys on the campus, and the women volunteered for office duty.

Some of the men had experience in the building trades, but others such as a former computer programmer, a retired school teacher and an erstwhile paper mill employee were skilled apprentices. However, all worked at a competent, cheerful, but not frantic pace, putting in four days a week and seven hours a day. The first group was enlarged by a second group that boosted the work force to 11 couples in February, and additional replacements arrived in March and April.

Meanwhile, the results at Lewis Cottage were nothing short of spectacular as the skilled MMAPers moved interior walls, replaced outmoded electrical wiring, installed new plumbing, repaired the roof, and thoroughly modernized the aging structure.

The Boys Ranch provided building materials and a few heavy duty power tools, but very little supervision was necessary, and when the job was done, an amazed observer suggested adding a word to the MMAP title, making it "Marvelous Mobile Missionary Assistance Program".

That suggestion was tabled due to the problem it would be a real tongue twister, but the Ranch staff agreed in principle, and one official pointed out that the labor provided free would have cost at least \$80,000.

That was the major gain for the Boys Ranch, but there were other benefits. MMAPers became adopted members of the Boys Ranch family, and by example shared their faith. They joined the Ranch and Central Office staffs at lunch, and were guests at the Wednesday night community meals which gave them an opportunity to get acquainted with Ranch youngsters.

Some had boys assisting them on the job at various times, and others played tennis with the boys. On Sundays it was not unusual to see MMAPers in the chapel service congregation.

Others just don't have the money to do anything special, and they ease their boredom by heading out to the streets where they run the risk of being led astray.

During the past decade, the Florida Sheriffs Youth Ranches Summer Camp near Barberville has provided a wholesome alternative for these unfortunate youngsters facing an otherwise bleak summer without guidance and loving discipline.

This year, once again, nearly 500 carefully chosen youngsters ages 10-15, will participate in five ten-day camping sessions. As in the past, generous donations designated to help sponsor campers are expected to make it possible for the youngsters to attend free of charge.

Sponsors for this year's camping session are still needed. Camp Director Bill Frye explains that

waiting lists of hopeful campers far exceed the hundreds of boys and girls that are actually helped each year.

"Every minute of the campers' days are packed with adventure, sharing responsibility and love," explains Frye. "For many youngsters, it's their first vacation, but it's also much more. The bonds of love and trust that develop between our coun-

selling staff and the young people works miracles in their overall attitude and selfesteem."

The staff includes deputy sheriffs who volunteer their time each year, as well as, mature young adults such as school teachers and college students who direct programs and serve as counsellors.

Campers enjoy a wide range of activities including swim-

ming, fishing, archery, horseback riding, hiking, arts and crafts and campfire sing-a-longs. Daily activities balanced between work and play teach youngsters to accept responsibility and recognize the value of sharing and teamwork.

Their most unique experience is getting to know the law enforcement people behind the badges in an informal setting. The reality of the

camp's slogan, "Law Officers Are Your Friends," is evident in the tearful good-byes shared at the end of each session.

Hard work goes into the planning and operation of the five camping sessions. Recently more than 30 volunteers put a fresh coat of paint on the buildings, raked leaves and shored-up camp sites in anticipation of the first session which begins June 10. The remaining sessions begin on June 24, July 8, July 22 and August 5, 1992.

# Gift Annuity Rates Due to Change

If you have been considering establishing a gift annuity with the Florida Sheriffs Youth Ranches, Inc., there has never been a better time. If you are over the age of 81 and act now, you will be able to capitalize on higher payment rates scheduled to be reduced after July 1st of this year.

The Committee on Gift Annuities, which meets every three years, adopted a new reduced payment schedule during its conference in Dallas in late April. The reduced payment rates will affect persons over the age of 81, capping the rates at 12 per cent compared to the current 14 per cent payment rate. The rates remain unchanged for persons age 81 and younger, see the chart and details on the following page (page 14), for a complete explanation of the Gift Annuity Program.

The Irrevocable Charitable Gift Annuity is an attractive avenue for anyone thinking of making a gift to the Youth Ranches for a number of reasons. The program allows for substantial cash gifts to the Youth Ranches while maintaining an income for life. The donor can deduct a sizeable portion of the gift from taxable income. The gift is sheltered from estate taxes and probate. The payment rates, shown in the charts on this page and in detail on the following page, are guaranteed for life at a substantially higher rate than currently offered by certificates of deposit, money market funds and most corporate bonds.

## Gift Annuity . . . A Gift That Gives and Provides Payments For Life

#### What is a charitable gift annuity?

A charitable gift annuity is a gift to help troubled boys and girls in Florida while providing a guaranteed lifetime income for the donor.

It is an irrevocable agreement by which you make a gift to a qualified charitable organization and receive fixed payments for life. It is also a gift since part of the payment is given for a non-profit cause. Charitable gift annuities are recognized by state and federal authorities as a way to make a gift, and they have been around for many, many years.

The amount of income one receives is based upon the amount of the gift and the age of the donor. The older the donor, the higher the gift annuity rate.

A portion of the gift is immediately tax deductible as is a portion of the income.

Organizations issuing gift annuities are required by Florida law to meet precise financial standards and be registered. The Youth Ranches was the first organization in Florida to be issued a permit to write charitable gift annuities. The Youth Ranches permit number is DAAP-74-1. The Committee on Gift Annuities meets every three years to set the uniform annuity rates and the Youth Ranches is a sponsoring organization of this group.

You are encouraged to consult your attorney or other professional advisor for advice and assistance.

#### **\*EXAMPLE:**

A \$10,000 investment in a Florida Sheriffs Youth Ranches, Inc., Gift Annuity will give a <u>70-year-old</u> person the same after tax cash payment each year for their remaining life as a \$10,000 Certificate of Deposit or similar fixed rate investment that yields 10.53% assuming a 28% marginal tax bracket.




