


# National Recognition for Rancher and Alumni

The boys who have met this goal will ride with Chaplain Morales to a local coffee house in town where the boys gather and begin reading favorite passages aloud. Sometimes, there is a lively discussion and other times, a pensive, almost solemn time of reflection and thought.

Many of Chaplain Morales' questions begin with "What do you think about...?" This gives the boys an opportunity to form thoughts, opinions and reflect upon the choices made by the characters in the book.

It is a privilege to be a member of the Boys Ranch Book Club and this engaging opportunity has improved the confidence, public speaking skills and reading comprehension abilities of the boys and adults alike. We are proud of these young men as they strive to better themselves in so many valuable ways. Gathered in a circle, the boys discussed the most recent book, <u>By Reason of Insanity</u> by author Randy Singer. Chaplain Morales asked, "Is the insanity plea fair or unfair?"... "Was temporary insanity a good justification for a crime?"... and "Can insane people also be intelligent people?" The boys discussed mounting circumstances of the crime, the thoughts and feelings of the victim and the motives and choices of the accused. It was an interesting and insightful discussion.

DONALD RALPH COOKE August 19, 1917 ~ March 13, 2004



Mr. Donald Ralph Cooke was born in Montreal, Canada. He was born to Ralph and Nancy Cooke and had three siblings. Mr. Cooke was an incredibly bright man and the only person in his family to obtain a college education. He worked his way through college as an athlete, boxing coach and instructor. Mr. Cooke earned his Master's Degree in Business Administration at The University of Western Ontario in London, Ontario, just outside of Toronto, in 1940. It is one of Canada's oldest universities, founded in 1878 by Bishop Isaac Hellmuth and the Anglican Diocese of Huron.


Mr. Cooke came to the United States of America in 1942. He thought this was a great country and wanted to start a business of his own. He became a US citizen and took a job as a radio announcer in Michigan. His business was known as Donald Cooke, Inc., and was located at 666 Fifth Avenue in New York City. Mr. Cooke was a New York Sales Representative for United States and Canadian radio and television stations and magazines

He married Dorothy Hertha McLaughlin at St. Thomas Episcopal Church in New York City, New York. They enjoyed 56 years together.

Mr. Cooke believed a strong education helps make a man very successful. He was living proof of this theory and his wife Dorothy has built this school as a tribute to him. Mr. Cooke was an honest businessman, full of integrity and humility. He also had an excellent sense of humor, a very quick wit and was a gentleman in every sense of the word.

Mr. Cooke was born in Montreal and resided in Toronto, Canada; New York City; Millbrook, New York; Ashville, North Carolina and Port Saint Lucie, Florida. He enjoyed his life tremendously and truly lived the American Dream.

I personally dedicate this beautiful School in honor of my husband DONALD RALPH COOKE and to all the boys here who have and will pass through to become as fine a gentleman as Mr. Cooke.



Several boys at the Florida Sheriffs Boys Ranch learned the lessons taught by many hours of hard work and dedication as they made a commitment to show a heifer at the local county fair. Months ago, the Ranchers selected a young calf and began to build trust with the animal. Then, as the fair drew near, the boys were teaching the calf how to walk with them on a lead line.

Hours of work at the barn taught the boys to be both persistent and patient. Farm Manager Jeff Parker expected the boys to handle all the chores related to the care of their heifer, including keeping them fed, watered and in a CLEAN stall. As the fair drew near, a small crowd at the Boys Ranch began to gather on a weekly basis to encourage the boys as they practiced "showing" their animals.

Finally the Suwannee County fair had arrived! You could see the pride in the boys' statures as they walked into the arena with their shoulders back and their confidence strong. The boys kept their eyes on the judge as they knew a part of the test would be a thorough questioning about their heifer. Each boy did his best to answer accurately and completely...standing ready for the final walk around the arena.

When the judging was complete and ribbons awarded, our boys still held their heads high. While blue ribbons went to other competitors, our boys knew they had won something they would keep forever – a sense of accomplishment, proof of their dedication and the satisfaction of representing the Boys Ranch with pride and dignity!




