
many more describe our Alumni from the Florida Sheriffs Boys Ranch. Many of them gathered with their families at our Alumni dinner to celebrate the success in their lives.

Rememberine Bobby Vicenzi

Founded in 1957, the age of our Alumni stretches from their late teens into their late 60's and early 70's. Each year we inscribe the names of deceased Alumni on the memorial wall as a permanent remembrance of those we have lost.

Sadly, this year, we inscribed the name of Boys Ranch Alumnus Bobby Vicenzi on the memorial wall. Bobby was only 45 and died as a result of a medical condition that took his life on a boating excursion during his daughter's 16<sup>th</sup> birthday.

Tragically gone too soon, Bobby had already made his mark as a member of the Alumni Association. Bobby won the Tweed Trophy in 1981 and continued to enjoy his love of riding horses throughout his life.

In 1991, he wanted to add his personal touch to the Tweed Trophy presentation and ordered a one-of-a-kind, handmade belt buckle for the boy who won the prestigious horsemanship award. Every year, thereafter, Bobby continued this tradition and it became a regular part of our Boys Ranch Open House.

This year, in Bobby's absence, his wife, two daughters and granddaughter made the special presentation. They have vowed to keep his memory and this tradition alive every year as a tribute to him.

President Roger Bouchard recognized that Bobby himself never received a Tweed belt buckle so he had one made and framed, especially for Bobby's family. It was a special presentation to honor and remember Bobby Vicenzi who never forgot about his brothers at the Florida Sheriffs Boys Ranch. \*

Bouchard, "Take the chairs back to the Ranch and put them in the Alumni Building so everyone can see the boys' great work!"





# "A Boy's Buddy"

Internationally recognized artist Barry Barnett was contacted by LT. Tommy Bertolomi of the Volusia County Sheriff's Office and asked to create a painting for the Sheriff's of Florida. After much thought and consideration, they decided to honor Sheriff J.M. "Buddy" Phillips, who is also known as "The Sheriff of Florida" and celebrate the countless young people who have been helped by the Florida Sheriffs Youth Ranches.

After several visits to the Florida Sheriffs Boys Ranch near Live Oak, Mr. Barnett painted the masterpiece known as "A Boy's Buddy" with Sheriff Buddy Phillips shown as a young Deputy Sheriff bringing a boy to the Ranch where he could start a new life.

The original painting is permanently displayed in the Diaz Administra-

or other avenues to help engage the teen in a comfortable relationship. We take a "Rancher centered" approach and start with things that are naturally enjoyed by the youngster and build up from there.

On-site therapy is especially beneficial because most kids do not just face challenges at "appointed" times. Their therapist is on campus and available as needed to listen, counsel and create a sense of accountability. From the most severe crisis situation to the daily preparation for the next step in a youngster's life, our Therapists

This is a far cry from the skinny, tough teen who arrived at the Ranch just two years ago. "I was a pretty angry young kid whose grades were in the pits," he said matter-offactly. "Home was not a place I wanted to be and my attitude showed it."

"When I heard about the Ranch, I was skeptical but knew anything was better than a future filled with trouble." Soon after arriving, Kodie earned a spot on the Riding Ranchers team. He enjoyed working with horses and began to demonstrate patience, discipline and a good work ethic.

As the school year went by, Kodie's grades improved significantly. He wanted to move from the school "on campus" to the school "in town" and knew it would take both good grades and good behavior. Kodie finally reached his goal and entered Suwannee High School this fall.

the new kids would need as they adjusted to life at the Ranch. Kodie immediately stepped up and took on this challenge with a sense of confidence and pride.

Striving to carve out his future, Kodie plans on a strong finish during the next two years of high school. He would like to go to college and eventually become an Agricultural Teacher which will blend his love of animals, earth and the outdoors with his leadership skills and talents. Kodie is a bright, healthy example of the change that can be made in the life of a boy in need. "The Ranch is the best place in the world for a kid who needs help. 




